A litigant who is aggrieved by the decision of a court and who wishes to appeal against it directly to the Court on a constitutional matter shall, within 15 days of the order against which the appeal is sought to be brought and after giving notice

to the other party or parties concerned, lodge with the Registrar an application for leave to appeal: Provided that where the President has refused leave to appeal the period prescribed in this rule shall run from the date of the order refusing leave.

Rules of the court

Today the Constitutional Court handed down judgment in a matter concerning the power of the Public Protector to “take appropriate remedial action” and whether her finding that President Zuma is required to pay back a reasonable portion of the money spent installing non-security upgrades at his private residence (Nkandla) in his personal capacity is binding.
